Director candidate proposal

Criteria for the shareholders to propose director candidate during the 2011 Annual General Shareholders' Meeting

Objectives

Prinsiri Public Company Limited provides equal treatment for all shareholders. To promote good corporate governance and encourage shareholders' participation, the company allows shareholders to propose candidate to be considered as the company's director according to the company's criteria for the 2011 Annual General Shareholders' Meeting.

Criteria

1. The shareholder, or group of shareholders, who wishes to proposed director candidate must have at least 0.1% or the company's total shares and has continuous holding period until the agenda proposal date of at least 12 months.

2. Proposing director candidate

The shareholder who fulfills criteria no.1 can propose director candidate, which the candidate(s) shall meet criteria with no exemption under the laws regarding public company, securities and exchange laws, other related laws and the Company's good governance policy, by filling out the form "2011 Annual General Shareholders' Meeting Proposal Form" or send the proposal unofficially via facsimile at 0-2617-6910 or through corporate secretary's E-mail ritima@prinsiri.com before sending the original "2011 Annual General Shareholders' Meeting Director Candidate Proposal Form" and attach complete evidence of shareholdings, which includes certificate from securities broker or other evidence from Thailand Securities Depository Company Limited or the Stock Exchange of Thailand, and the consent letter from the nominated candidate, and other documents that provide information about proposed candidate such as education or work experience, and other additional document that might be useful for board's consideration (if any) to the company during to 31 January 2011 at following address.

3. The nomination sub-committee of the company will consider qualified candidate with complete, accurate, and adequate evidence and propose to the board of directors for consideration.

The names of candidates who receive consent from the board of directors will be in the director appointment agenda in the 2011 Annual General Shareholders' Meeting. For those who does not receive board consent, the company will notify the shareholders with the clarification on the company's website or other appropriate means of communication within February 2011.
